- 3. Startup Funding Through Child Care Health Consultant
  Meyer walked through a presentation on resources available through Childcare Aware of Kansas.

- 4. Kansas Action for Children Resources

12.9% of household income is spent on childcare in Ellis County. That is nearly twice that of other communities. 7% is the target for income spent on childcare.

Hudson-Hamilton shared that Early Childhood Connections is seeking partners to provide daycare for children receiving DCF services.

- 5. Questions to Address as a County
  - What are our specific needs for childcare in Ellis County?
     Wiles shared that the greatest needs being identified in a majority of counties are childcare for 18 months and under as well as 2<sup>nd</sup> and 3<sup>rd</sup> shift childcare. Childcare for children with special needs is also a critical need.
  - What should our process for improvement look like to address the needs?
     The task force spoke about conducting a community survey to start its process form improvement. The next meeting will focus on that survey, its questions, timeline, and how it will be shared with the community.
  - What would it take to establish additional daycares or a center?
  - Who is not here today and needs to be to move forward and address the issue?
     The United Way of Ellis County and DCF were identified as organizations that should participate in this effort.
  - What challenges exist for current providers in addition to the ones listed below?
    - a. Keeping a house a home and business simultaneously
    - b. State regulations in Kansas are more stringent than in surrounding states
    - c. Making a profit as a business model
    - d. Classification of infants for available spots
  - Possible Incentives to Consider for Current and Future Providers
    - a. Offset the cost of liability insurance for providers
    - b. Utility/internet discounts
    - c. Food assistance/reimbursement
    - d. Equipment
