## 2. Ellis County Childcare Survey Question Review

- a. Discuss questions and answersWiles will send out the questions for the committee to review.
  - A question that will be added will speak to finding out if responders are licensed but not currently providing childcare.
  - Another question that will be added will ask providers what their preferred capacity is.

## b. Timeline for survey

The task force agreed to have the survey open as soon as possible and keep it open through December 31, 2021.

- c. Distribution process Wiles said the survey will have greater success if everyone can send it out through their personal and professional communication channels and recommended these additional channels:
  - Official press release to all media outlets
  - Share with all the local school districts
  - Share with all childcare providers through their communication channels.
  - Schedule a Forward Ever interview with Gary Shorman

- 3. Victoria Senior Center Facility Discussion

Jeff Pfeifer presented his project to the task force. He purchased the 42,000 sq. ft. assisted living facility in Victoria. He is interested in including childcare in the facility and is currently looking to find funds to pay for someone to assess the facility to identify the integrity of the structure.

- 4. Questions to Address as a County
  - What are our specific needs for childcare in Ellis County?
  - What should our process for improvement look like to address the needs?
  - What would it take to establish additional daycares or a center?
  - Who is not here today and needs to be to move forward and address the issue?

No discussion occurred with these questions.

5. Facebook Group – Childcare Task Force of Ellis County

Wasinger shared that Ruder started the Childcare Task Force of Ellis County Facebook page and invited all task force members to join the group and be a part of the discussion. Wasinger said she posted a question in the group to start getting feedback from childcare providers. Some providers have publicly responded, while others preferred to remain anonymous with their feedback. The ideas generated from that discussion will be tracked on future agendas to guide our efforts.

- 6. What challenges exist for current providers in addition to the ones listed below?
  - Keeping a house a home and business simultaneously
  - State regulations in Kansas are more stringent than in surrounding states

- Making a profit as a business model
- Classification of infants for available spots

Wasinger asked for committee members to share challenges they hear from providers so they can be added to the list.

- 7. Possible Incentives to Consider for Current and Future Providers
  - Offset the cost of liability insurance for providers
  - Utility/internet discounts
  - Food assistance/reimbursement
  - Equipment

The task force will continue to update ideas for incentives at future meetings.
